Consideration of approval of the Diploma, Degree, Pharm.D and Pharm.D (Post Baccalaureate) course in Pharmacy and examination in Pharmacy.

The following resolutions moved by Prof. M.D. Karvekar, Dr.H.G.Shivakumar & Shri M. Venkata Reddy and seconded by Shri Ramesh Kumar Leekha, Dr. M.K. Unnikrishna Panicker & Shri Salim A. 
