## Score Reporting Policies

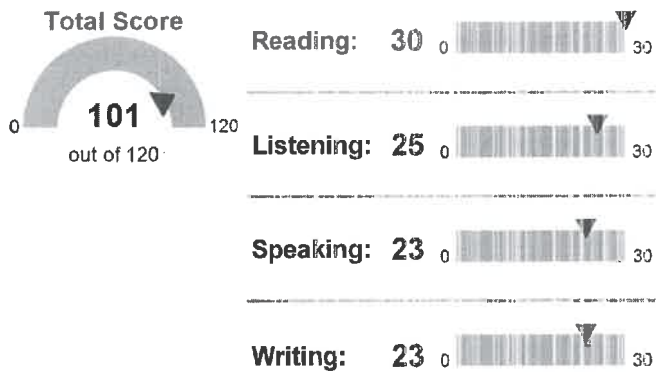

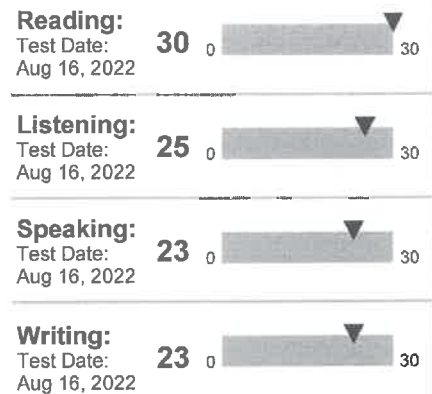
